We will not be able to schedule an assessment date especially for you.
- c. Access to the exam is your completed workbook in black or blue pen. If you do not hand in your workbook, you will not be allowed to write the exam and you will forfeit your free summative assessment (Refer to nr. 1. c.i).
- d. No extensions will be granted without a *valid reason.
- e. If you do not submit your resubmission of the formative workbook without a *valid reason on the date communicated, you will be charged for non-submission (Refer to nr. 1.j).
